In June Royce, our grandson, fell from his bed and broke his leg. The doctor at the hospital where Mary Beth took him for treatment accused Mary Beth and Oscar of abuse. As a result, the Department of Family and Children Services took the children away from them. Mary Alice traveled to the states so that the court could assign her custody, and the family could live together again. Mary Alice has enjoyed seeing and taking care of her grandsons, Dominic and Royce during this time. It wasn't easy living with Mary Beth and Oscar, especially with all the cultural differences in the family, but God was good. He definitely gave Mary Alice many opportunities to learn and try to practice what a true servant is – to love, no matter how others respond. Jesus was the perfect example of a true servant for us. Thank you for your prayers for Royce; God has healed his broken femur bone completely. In a court hearing on July 29<sup>th</sup>, Mary Beth was told if she put child safety locks on the toilets and safety gates on the stairs, and she and Oscar would attend a Parenting classes at the Department of Family and Children's Services that custody of the children would be restored to her and Oscar in a hearing now scheduled for August 27<sup>th</sup>. Since Mary Alice currently has custody of the children, that means she will not be able to return to Peru until the end of August. Please pray that God will give wisdom to Oscar and Mary Beth to love and take care of their children and the ability to complete the requirements of the court.

Please pray for Mary Alice as she continues to care for the grandchildren and for Arthur as he continues the work in Peru without his helpmate.

Arthur has been super busy in Peru getting ready for an August medical campaign that will be conducted in Yuarj Marca with a team from Halltown Baptist Church. He has been inventorying, buying, and packing medicines and supplies, getting government approvals, and making arrangements for transportation, food and lodging for the team. The entire team has 49 members and is made up of 10 people from North America, six missionaries from TMS Global, and about 33 Peruvians.

The next to the last week in July, Arthur signed a contract to rent a different house in Peru. Before and after the medical campaign in August, we will be moving everything little by little. The new house is smaller, so please pray for wisdom for us as we try to get rid of many things as possible. The good thing is that it is not very far from our other house. It is a house in good condition, and we know the people that are the owners. It will be a big change for us, because we have lived in the same house since we arrived in Peru in 2001. 
Please be in prayer for each one of our workers and for each one of the ministries and projects, the discipleship ministry, the evangelism and church planting ministry, the prayer
